

## **ORDINANCE NO. 2010 - 110**

### ***An Ordinance Amending Section 13C.05(A) Water and Sewer User Service Rates, Charges***

BE IT ORDAINED by the Mayor and Aldermen of the CITY OF HARVARD, McHenry County, Illinois, as follows:

SECTION 1:: That Chapter 13C.05(A) Water and Sewer User Service Rates shall be amended to read as follows:

#### **13C.05 WATER AND SEWER USER SERVICE RATES, CHARGES**

A. Rates, Charges Established: There shall be, and there are hereby established, rates and charges for the use of and for the service supplied by the City's combined waterworks and sewerage system. Except as otherwise provided herein, said charges shall be based on the amount of metered water usage read to the lowest increment of 100 cubic feet. In addition to the metered water usage charge there shall be a maintenance fee and debt service charge, which is determined by the amount of revenue funds required for the principal and interest payments due for all outstanding bonds authorized and issued by the City for financing improvements to the system. The charges and fees, as well as the maintenance fee, shall be billed every two months are set as follows:

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment

shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.




