**Liquor License Applications
2024**

1. Corporation checks: All applicants who had a corporation status are in good standing with the Illinois Secretary of State.
2. State Liquor License Checks: Most applicants that have had a liquor license previously, and still have a valid Illinois liquor license. R&R Alehouse now has an Active LLC and the brothers Rutkowski have cleared their background checks.
3. CAD/Local checks: A check through CAD revealed police contacts of some of the locations applying for licenses. Some of these police contacts include the Liquor Compliance Checks done in the summer of 2023 (HAPD-23-005925). Apart from the Liquor Compliance Check failures at various locations, there are no major violations that would prevent an applicant from obtaining a renewal of their liquor license.
4. DBA checks: The Hub Lounge, Thunderbird, and Southside Tap are not incorporated, but have DBA's on file with the McHenry County Clerk's office that are in good standing. The County Clerk's Office stated that they have no record of McGarry's Bowl in Harvard, yet a check with the City has indicated that McGarry's Bowl has been grandfathered in from previous years.
5. Notifications of Arrest: The department has not received any notification from the State that would indicate that any liquor license holders have been arrested.

I found nothing that would keep any of the applying businesses from having their local liquor licenses renewed.
