

ORDINANCE NO. 2021 - 123

An Ordinance Amending Chapter 5, Boards and Commissions, of the Harvard Municipal Code

BE IT ORDAINED by the Mayor and City Council of the CITY OF HARVARD, McHenry County, Illinois, as follows:

SECTION 1: Effective upon the passage of this ordinance, Section 5.07, Mary D. Ayer Committee, of the Harvard Municipal Code is repealed in its entirety.

SECTION 2: Effective December 31, 2021, Section 5.05, Harvard Events Committee, of the Harvard Municipal Code shall be repealed in its entirety.

SECTION 3: Effective December 31, 2021, Section 5.06, Spirit of '76 Scholarship Committee shall be renumbered as Section 5.05.

SECTION 4: Effective May 1, 2022, Section 5.04.B, Parks and Recreation Board, Appointment and Qualifications, of the Harvard Municipal Code shall be amended to change the number of members on the Parks and Recreation Board and shall read as follows:

B. Appointment and Qualifications: The Mayor shall make the appointments to the Park Board with the advice and consent of the City Council. The Park Board shall consist of four sitting Aldermen and up to three ~~five~~ at large citizens. To be eligible to serve on the Park Board a person must be 18 years of age or older and be a City resident. The Mayor shall designate one of the Park Board members to serve as Chairperson, a Vice-Chairperson shall be appointed by the Mayor with the advice and consent of the Park Board. The position of Chairperson shall be reviewed on an annual basis. The Vice-Chairperson shall act in the absence of the Chairperson. The Chairperson shall be the presiding officer of the Park Board and ensure all meetings are conducted in compliance with the Open Meetings Act.

SECTION 5: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 6: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 7: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.




