DRIVING UNDER THE INFLUENCE OF ALCOHOL / AGGRAVATED FLEEING AND ELUDING A PEACE OFFICER / UNLAWFUL POSSESSION OF CANNABIS / UNLAWFUL POSSESSION OF CANNABIS WITH THE INTENT TO DELIVER

On 08-01-22 at 0054 hrs, Julius M Williams (m-39 yoa), 604 E Grant Hwy Apt #7A, Marengo was arrested for Driving under the Influence of Alcohol, Aggravated Fleeing and Eluding a Peace Officer, Unlawful Possession of Cannabis, and Unlawful Possession of Cannabis with the Intent to Deliver after officers initiated a traffic stop on a 2016 Nissan driven by Williams at the intersection of S Division St and W Brink St for erratic driving.

Williams fled from Officers in the vehicle before being involved in a property damage accident at the intersection of E Thompson St and Marengo Rd disabling the vehicle. Williams then fled on foot from the vehicle and was apprehended after a short foot pursuit.

Williams was criminally charged with Aggravated Fleeing and Eluding a Peace Officer, Obstructing Justice, Resisting a Peace Officer, Unlawful Possession of Cannabis more than 100 grams but less than 500 grams and Unlawful Possession of Cannabis with the Intent to Deliver.

Williams was issued two citations for Not Driving on the Right Side of a two Lane Road, Driving While License Suspended, Driving under the Influence of Alcohol, Operating an Uninsured Vehicle, Fleeing and Attempting to Elude a Peace Officer, Failure to Reduce Speed to Avoid an Accident, two citations for Disobeyed a Stop Sign, and Unlawful Possession Cannabis-Driver. Williams was transported to the McHenry County Jail in lieu of bond.
