HARASSMENT THROUGH ELECTRONIC COMMUNICATION

On 11-15-22 at 1428 hrs, a Harvard Youth (m-17 yoa), reported they were currently being harassed and threatened through a social media platform.

After a thorough investigation on 11-22-22 at 0700 hrs, a Harvard Youth (m-16 yoa) was arrested and charged with one count of Harassment through Electronic Communication. The Youth was petitioned to McHenry County Court Services and transported to the Kane County Juvenile Detention Center.

AGGRAVATED BATTERY / MOB ACTION / DISORDERLY CONDUCT

On 11-16-22 at 1134 hrs, Harvard Police responded to the Harvard High School, 1103 N Jefferson St, after it was reported a fight ensued involving several students in the cafeteria. It was further reported one of the students received an injury that required the Harvard Fire Protection District to respond and transport the student to an area hospital. During the incident the fire alarm was pulled by a student which obviously exacerbated the incident, causing the school to be evacuated.

The Harvard Police Department worked cooperatively with Harvard High School Administration and the District 50 Superintendent. As a result of the investigation on 11-17-22 at 0955 hrs, a Harvard Youth (m-15 yoa) was arrested and charged with three (3) counts of Aggravated Battery, one (1) county of Mob Action, and two (2) counts of Disorderly Conduct. The Youth was petitioned to McHenry County Court Services and transported to the Kane County Juvenile Detention Center.
